### **Historical Models of Regional Integration**

- a) The rapprochement of states without challenging their sovereignty;
- b) Forced unification through territorial conquest, whereby a dominant power imposes its will even in the absence of consensus. World history offers numerous examples of forced unification projects achieved through the conquest of territories and the imposition of a foreign sovereign's authority. The collapse of empires often marked the end sometimes for extended periods—of such integration attempts.

### The Context of the Republic of Moldova

After the dissolution of the USSR: the choice between the European Union and the Customs Union.

With the direct involvement of the political class, society became divided into two opposing camps: pro-European vs. pro-Moscow.

Even after three decades, Moldovan society continues to face the challenge of positioning itself between these two orientations.

➤ Effects: numerous vulnerabilities have emerged in the development of the Republic of Moldova, significantly hindering its progress in the European integration process.

The political goal of integration is for Russia to acquire the capacity to represent the interests of the Customs Union member states in international forums such as the United Nations (UN), the World Trade Organization (WTO), and the G20.
